

It is proposed to form a panel for Two Ex-Cadre posts of Vigilance Watcher in Level-4 (equivalent to PB-I, Rs.5200-20200, GP -2400 of the 6th PC) or one level below ie. Level-3(equivalent to PB-I, Rs.5200-20200, GP-2000 of 6th PC) in Vigilance Department of RWF from amongst suitable volunteers viz. Constables/Head Constables working in Railway Protection Force of Zonal Railways and Production Units.

The terms & conditions for volunteering will be as under:-

1. Vigilance Watcher post is purely temporary and a tenure post.
2. The above post does not carry any special pay etc.
3. The post of Vigilance Watcher is an ex-cadre post in Level-4 (equivalent to PB-I, Rs.5200-20200, GP -2400 of the 6th PC) or one scale below ie., Level-3 (equivalent to PB-I, Rs.5200-20200, GP-2000 of 6th) PC) of RSRP Rules 2016.
4. Volunteers should not have worked as Vigilance Watchers in the past.
5. They should have a minimum qualification of SSLC and 5 years of service in the RPF department, as on the date of notification.
6. The normal tenure of Vigilance Watchers will be three (03) years and may be extended in individual cases deserving special merit.
7. Volunteers should not have any ongoing DAR/Vig./SPE cases against them and also not undergoing any punishment.
8. They should not have any past Vigilance history.

9. Volunteers should be employees, whose integrity is beyond suspicion.
10. They are expected to willfully and physically be fit to stand the strain of long and continuous journeys and camp life.
11. They may be repatriated to their parent department at anytime without assigning any reasons.
12. Volunteers should have a minimum residual service of 06 years.
13. Applications should be submitted in the proforma enclosed complete in all respects and duly signed by the applicant and the respective controlling officer/s.
14. Applications should be submitted through proper channel and after obtaining necessary approvals including Vigilance clearance from respective Railways.
15. Controlling officers should forward the applications through proper channel directly to CVO, Vigilance Department, Rail Wheel Factory, Yelahanka, Bangalore-560 064. The last date for submission of applications will be 23.01.2024. Application/s received after the due date will not be entertained under any circumstances.
16. The Volunteers will be subjected to a written/screening test and viva-voce before considering them for posting as Watcher.
