It has come to notice of the Board that Shri S.Ramachandra Rao, Sr.Clerk under ADEN/JAD, WAT Division of East Coast Railway is projecting himself as President/General Secretary of "All India OBC Railway Employees Federation" and as Chairman of "Forum for Social Justice and Anti Corruption" with an official address viz. Room No.48, Rail Bhavan, New Delhi.

It is hereby clarified that, in terms of Board's letter of even number dated 6.10.2020, CEC headed by Shri Dhruv Dev Yadav had been regularised for the year 2016-2018 in order to streamline only, as no list was circulated by Board for the said period and recognize the list of elected office bearers submitted by Shri.Purushottam Yadav and Shri Virendra Singh as President & General Secretary respectively, for the year 2017-19, and Shri S.Ramachandra Rao is not a President or General Secretary since 2016. Therefore presenting himself as President or General Secretary before Railway officials and furnishing false affidavits and producing false documents before the Hon'ble Courts is highly objectionable.

As regards "Forum for Social Justice and Anti Corruption", this Ministry have not recognised this organisation and nothing to do with any of the representations received under this letter head/banner. Therefore using the official address viz. Room No.48, Rail Bhavan, New Delhi is highly objectionable.

It is therefore advised not to entertain any of the representations furnished by Shri S.Ramachandra Rao as President or General Secretary of AIOBCREF and also not to give cognizance to any of his representations under the banner "Forum for Social Justice and Anti Corruption".


