

Eligibility Criteria:

- 1) Staff working in Ministerial cadre in any department, Personnel Inspectors, Welfare Inspectors, & Chief Law Assistants, in Railway- excluding stenographers and typists - in the scale Pay Matrix Level-7 (equivalent to PB-II, Rs.9300-34800, GP-Rs.4600/- of 6th PC) or one scale below, i.e. in scale Pay Matrix Level-6 (equivalent to PB-II, Rs. 9300-34800, GP-Rs.42007- of 6th PC, on a regular basis.
- 2) Candidate should have completed at least five (05) years of continuous service, as on the last date for receipt of applications.
- 3) The minimum educational qualification required is five years Apprenticeship from Railway/Diploma/Graduate in any discipline.
- 4) Candidate must have sound integrity, and should not be figuring in any current Vigilance/SPE/DAR case. NO penalty (Major or Minor) should have been imposed in any past vigilance case.
- 5) Staff who have already completed their tenure in the vigilance organization of Zonal Railway/Unit/Railway Board as 'Investigating Inspector (Vigilance)' or 'Vigilance Inspector' shall not be considered.
