कृपया उक्त विषय पर यथा संदर्भित बोर्ड के दिनांक 31.03.2021 के समसंख्यक पत्र का अवलोकन करें, जिसके तहत रेलों को सूचित किया गया था कि संवेदनशील पदों पर काम करने वाले जिन कर्मचारियों का आवधिक स्थानांतरण नहीं हुआ है, उनकी समीक्षा की जाए और कोविड-19 महामारी द्वारा उत्पन्न असाधारण स्थिति के कारण इन्हें 30.06.2021 तक लंबित रखा जाए।

2. मौजूदा महामारी की स्थिति को देखते हुए, दोनों फेडरेशनों अर्थात एआईआरएफ और एनएफआईआर के अनुरोध पर बोर्ड द्वारा इस मामले की पुनः समीक्षा की गई है और सक्षम प्राधिकारी द्वारा यह विनिश्चय किया गया है कि संवेदनशील पदों पर काम करने वाले कर्मचारियों के आवधिक स्थानांतरण आदेश 30 सितंबर, 2021 तक लंबित रखे जाएं।
