III in PB-I Rs. 5200-20200/-+GP Rs. 2400/-(Level-4 as per 7<sup>th</sup> CPC ) are to be filled up by Promotion by selection from Shorthand knowing Clerks/Typists in GP 1900 & above and 25% vacancies in the category of stenographer Gr. III in PB-I Rs. 5200-20200/-+GP Rs. 2400/-(Level-4 as per 7<sup>th</sup> CPC ) by General selection from serving Group-C employees in GP Rs. 1800 and above with Knowledge of shorthand.

1. Above Selection will comprise of written examination, speed test in shorthand in 80 W.P.M. and Viva-voce followed by scrutiny of service record and APARs of the candidate who will qualify in the written test, speed test and Viva-Voce. The employees must secure 60% of marks in professional ability as well as in the aggregate. In the case of SC/ST employees must secure 50% marks in Professional ability as well as in the aggregate for empanelment against SC/ST vacancy. **The panel will be formed strictly in order of merit.**


